LRC Floorplan (Invited Guests: Beth Rhodes, Project Manager, Ken Kerch, Senior Project Manager, Isa Bey, Senior Project Engineer)

The Senate received an update on floorplans and building progress. The library will have space on two floors. Extra reinforcement is going in to support the stacks. There will be 7 classrooms, including one smaller than average, one 48-seater, one 70-seater, and a 270-person event space, which can be partitioned. Each floor has one (1) all-gender bathroom for all users with private lockable stalls. There are 5 learning community spaces, each with kitchenette.

OER/Textbooks Update from Ron Oxford

- Academic Senate is providing one unit for textbook work. Ron Oxford will be the point person. This is in addition to the duties/hours that he and Michelle have dedicated to OER/ZTC work which is primarily in assisting faculty members in developing and choosing OER/ZTC textbooks.
- CC Echo, which provided funds to make OER textbooks DEI-friendly, is wrapping up. Anthropology will be the next pathway. The OER librarians will submit information to the Chancellor's Office to put COM in a cohort with other colleges. COM will receive 180-200k for this over the next 3 years.
- OER librarians will develop marketing strategies to make students aware of pathways. They will ensure that degrees, already mostly ZTC, are properly advertised. They will also coordinate with the bookstore to align offerings with ZTC classifications for classes.
- XB12 Designating Textbook Cost: XB12 will require a textbook cost designation for every course in the catalog, including no cost, low cost, costs paid by the college, and required purchase.
- Library Textbook Loan Program (LTP) Phase-Out: The Library Textbook Loan Program (LTP) at COM is being phased out.
- The library will purchase more calculators to offset math textbook costs.
