Curriculum			
New Discipline – Social Work (SW) and Human Services:			

- Introduction of three new courses in Social Work, with an emphasis on an "earn and learn" model.
- Focus on creating pathways for students to gain jobs, leveraging partnerships with the county.
- The new degree would require establishing a new discipline, not a department, under counseling.
- A counselor with equivalency in Social Work could teach these courses.
- Emphasis on addressing social services workforce shortages, especially in Marin and the Bay Area, with interest from psychology majors.

Course Deactivations:

- The Curriculum Committee voted to deactivate 10 courses: ECE 223, 226, 135; Econ 215; Poli Sci 117, 215; KIN 124; VOCN 6010, 6015, 6020.
- Courses can be reactivated with an updated Course Outline of Record (COR) and presentation to the Curriculum Committee.
- Special concern was noted for Poli Sci 117, focused on the Middle East, as it was deferred due to faculty availability issues.

DEC	POCR process clarification for courses in a series, meaning courses where concurrent enrollment happens but they have separate SLOs. If offered online, each course must have different POCRd' canvas shell. DEC was getting pushback. Senate made no objections.
