- a. **Curriculum (Cullen)**: GE committee (ad hoc) will be meeting soon and Senators are invited to join (today). Senate needs to update APs (minimum of 5). CC meets today as well.
- b. **PRAC (Coulson):** hasn't met yet.

- V. Invited Guest: Eresa Puch: VP of Academic Services. Follet's contract is expiring. Shared PPT from Follett , presented at a meeting with administration. They are presenting 3 potential business models. They are requesting a 30 min meeting with the executive team.
 - 1. Virtual Store. Online shopping and website support. District is not currently charging for rent. District can only charge rent if store makes 100k in revenue. Providing free space currently. Virtual store = district would save on operating costs.
 - 2. Management Fee: district would pay for current level of services, 3k/ month, 0% commission to district.
 - 3. Access Program: purported to provide equity: students could pay a flat fee on credit based on credit hours, for access to all books in digital form.
 - It is unknown what the fee would be for Option 3.
 - Students who need books often need physical books (in particular programs).
 - Amazon is easier and cheaper for students.
 - The senate expressed frustration that an agreement reached had been abandoned (for class sets of textbooks and elimination of contract with Follett).
 - Admin needs to commit to a truly equitable textbook program.
 - Follet has not been helpful gathering data for OER program.
 - ESL in particular needs physical books and students don't necessarily have credit cards or Amazon prime accounts or computer skills to order.
 - This is a part of 10+1. Needs some creative thinking, and hopefully administration can provide guidance and commitment.
- VI. Invited guest: UPM President Patrick Kelly: PK attended to give an update on contract issues related to 10+1.
 - Article 8: Discussed changed processes involving the Union-District Workload Committee (UDWC) and Curriculum.
 - **Chair & Coordinator Duties:** Updated definitions and duties; monthly department meetings may be required.
 - **Evaluations:** Minor process changes, new joint meetings at beginning of process will be permitted to save time, DE evaluation form updated, probationary faculty can evaluate beginning year 3.
 - **Grants:** Discussed AI Feedback Learning Lab Grant and the Bus Clause for grants affecting curriculum.
- VII. **Program Discontinuance**. Deferred. The Senate will recommend changing the numbers of the related APs to a more logical sequence.
