(CC to bring Course Catalog – look up degree info, lower division major prep?)

- Expanding units ~ course load need to ask for student feedback to recalibrate class
- Existing course revision (provide current evidence) vs New course (no current evidence)
- G.E. patterns?
- C-ID Descriptor (use this to help develop course)
- Part of pathways?

CC process re presentation of new or revised course outlines:

- Does the committee say "yes" or "no" after presentation?
- Suggestion that the CC take a week to evaluate before giving feedback
- 1st present to Academic Senate to get okay to move forward, then to CC

Process for Class Max

- A Joe distributed a handout from the 2016 Curriculum Institute position paper on Class Size. Discussion followed on how the CC should work with UDWC to address Class Size issues.
- UDWC needs to be involved in conversation
- Nancy Willett's rubric starting point of discussion
- UDWC has a class minimum requirement
- (Sara) CC can support reduced class size based on pedagogy argument
- D.E. maximums are too high to provide effective delivery of content to students (e.g., large enrolled classes in Anthropology, Biology, Psychology, Business, Math)
- Foothill college has the ability to load in course details and program will automatically calculate workload
