- 4. Chair Announcements
  - Gina announced that we would continue to meet remotely based on the recent requirements of teleconferencing under the Brown Act.
  - A meeting was scheduled with our eLumen representative to ask about hiding certain parts of the DE addendum from the public view. Gina will report back afterwards.

#### **Discussion:**

- 1. DANC 109A, 109B, 260 changes rationale provided by Kristi Kuhn and presented by Gina and Grace as Kristi had teaching duties.
  - a. Reduce 109A and 109B, Conditioning and Injury Prevention I and II, from 4 hours per week to 3 hours per week to fit better in the block schedule and help enrollment. The change is on par with other CCC Dance discipline degree requirements.
  - b. Reduce DANC 260 Musical Production-Dance from 4.5 hours per week to 1.5 hours per week. Drama faculty was consulted for the change.
  - c. Add 109B to the AA in Dance, which will increase the degree by 0.5 units.

• There was a discussion about hour/unit, student unit, and compensation category. The group deliberated over the proposed hours change (1 lecture hour and 2 lab hours per week) and the Studio compensation rate. Then Derek moved to put DANC changes on the next consent agenda. Sara McKinnon seconded the motion. Vote: all approved.
