- Maria is doing a one now and has experience with POCR. The difference is that in-person you
 look at a snapshot, but online is a bigger picture and you have to dig through the Canvas shell.
 We do not nitpick people's syllabus when doing in-person or if they are covering the learning
 outcomes.
- Patrick said the most important piece to evaluate in either modality is the student-student interaction
- The form needs to be shorter and more of a checklist
- Workgroup is being coordinated to make changes to the form as requested by the Union

State DECO Update (agenda amended)

- Canvas studio will be supported
- Some @One courses will still be supported. However, OTD is not being offered
- STAC was sent out will review with DEC once Co-Chairs have had a chance to review the form

Dual Delivery

- Getting the equipment has been difficult
- Assign a faculty member to pilot equipment
