Meeting Topics

- DE Legacy Courses
 - ISER is due in December. 5-50% of courses will be reviewed by ACCJC. Random sampling. Legacy courses will be an issue if not aligned. ACCJC will be looking for RSI and engagement.
 - Kathleen will send an email to legacy faculty. Some have already reached out to her to move forward.
 - Likely just go alphabetically from A-Z by program
 - Need to build out a short course that provides faculty info on aligning
 - There about 20 legacy courses which should not be an issue if we have a plan
- DECO Report: New POCR process
 - Fewer hoops to jump through. No longer required to submit three courses which we did not have time to go through.
 - System will be different but will meet with our ID from CVC-OEI. It is up to the college to set up their own process. The ID will check our process and make sure we are on aligning as suggested.
 - You do not have to be a POCR school to be in the Consortium
 - \circ We are way ahead of many schools. We should pat ourselves on our back.
 - There is money available to get into the consortium faster. eTranscripts are our hold up.
