POCR Update

- Still struggling with process for courses that do not align and how to go to the dean for right of assignment.
- Courses that cannot pass cannot be taught.

POCR Designation

- Capstone Project
 - We completed our third meeting to be an official POCR school.
 - MUS 106 was submitted. There are a few items that need to be corrected. Once that is done, we will be certified and able to badge.
 - They did not look at the course at all. They just want to make sure we have a process.
 - We have a few things to work out in that process so that we are all in agreement about rubric items and alignment.

POCR Badge

- We are considering putting a badge in our own course registration system (not just on the CVC-OEI site) along with ZTC.
- o It is a lot of work and faculty should be recognized for that. Like a gold star.
- Will affect English which is a department that has multiple sections and qualified instructors.
- Might incentive faculty to do get reviewed.
