Key Takeaways

 Need to establish an institutional budget and process for video captioning to ensure ADA compliance

- In-person testing using Proctorio and student devices raises equity concerns; policy change may be needed
- New Canvas Design Plus sidebar coming in Spring 2024; will require content migration by Fall 2025
- Professional learning around AI is needed; exploring funding options for speakers and training

Topics

Video Captioning Budget and Process

- Need institutional budget for captioning beyond just DE courses
- Exploring options like monthly subscription plans (e.g. 30 min/month or \$18k/year)
- Challenges: older videos, third-party content, faculty awareness/training
- Proposed solutions:
 - More faculty training on easy captioning methods
 - Possible policy to make captioning part of evaluation process
 - Budget for outsourcing longer/complex videos
- Next steps: Conduct needs assessment, develop training, explore policy options

In-Person Testing Policies

- Issues with faculty using Proctorio for in-person exams on student devices
- Equity concerns around requiring personal devices, WiFi reliability
- Potential solutions:



- Use computer labs for online testing instead of personal devices
- o Update policy to prohibit requiring personal devices for in-class exams
- Reissue best practices guide for Proctorio use
- Next steps: Add to Academic Senate agenda for 11/17, explore policy update options

Professional Learning for Al

- Seeking budget for Al/innovation speakers and training
- Exploring funding options like leftover AB705 funds
- Looking at ongoing learning opportunities beyond just flex days
- Need to determine if this should be funded institutionally vs. just by DE

New Canvas Design Plus Tool

- New sidebar version coming Spring 2024
- Old version being sunset December 2025
- Will require migrating existing content to new version
- Faculty can opt-in to new version starting January
- Next steps: Stacey and IT to strategize rollout and migration plan

Next Steps

- Send out document to work on DEC goals
- Add in-person testing policy discussion to 11/17 Academic Senate agenda
- Explore funding options for AI professional development
- Develop strategy for rolling out new Canvas Design Plus tool
- Continue discussions on captioning budget and process

- Update and resend Proctorio best practices doc
- Strategize with Burton next week re new CidiLabs Design Plus sidebar rollout
