Discussion

- 1. ECE Stackable Certificates Kjit and Shaquam
 - (1) Conversion of the current Skills Certificate to a Certificate of Achievement (COA)

- "Foundations in Early Childhood Education", 12 units (ECE 101, 112, 114, and 115)
- Discussion on the limited value of the current Skills Certificate, as it does not appear on student transcripts.
- Proposal to convert the Skills Certificate to a Certificate of Achievement, which would provide official transcript recognition and greater professional value.
- The COA will be aligned with the current California Assistant Teacher Credential to ensure consistency with industry standards and enhance employability.

(2) New Infant/Toddler Specialization Certificate

- 2nd COA in ECE, new addition; requiring ECE 218 and 219 on top of the COA discussed above
- The Advisory Committee has recommended the development of a new add-on certificate focusing on infant and toddler education.
- The specialization is considered necessary for educators working with infants and toddlers to meet evolving industry requirements.
- It prepares students for the Associate Teacher Permit/Credential.

Discussion:

- Sara suggested including the teacher credential in the certificate title to make it clear to students what specific goal they are working towards.
- Shaquam acknowledged the suggestion but noted that the State is currently proposing a new naming matrix for teacher credentials, which may impact future changes.
- Gina and Cari proposed annotating the certificate description to provide additional clarity; however, it was noted that such annotations would not be reflected in systems such as DegreeWorks.
- Grace asked about the frequency of infant/toddler course offerings. Shaquam confirmed that these courses are offered regularly.
- Nancy commented on the template used for the COA presentation and inquired about the additional supporting documentation required for Career Education (CE) programs. Grace clarified that the additional documentation will be required after the certificates receive approval from the Bay Area Community College Consortium (BACCC).
- 2. Math Substantive Change proposals Dan Zaffran
 - (1) Math 122 Calculus II with Applications
 - Prerequisite change: Remove Math 104 or 109 from prerequisites; Math 121 will be the sole prerequisite.
 - Unit change: Increase credits from 3 units to 4 units.
 - Wrap the needed contents from Math 104 & 109 into Math 122, resulting in increasing 1 unit for Math 122.
 - Proposal start term: Fall 2026 (on schedule Spring 2027)
 - (2) Add a companion course for Math 124 Analytic Geometry and Calculus II
 - Similar to MATH 123C; MATH 124C: 0.5 SU, 1.5 hours/week, 1.5 TU

- On schedule Fall 2025
- Not transferable

Discussion:

- Gina asked if the department has data on the success of companion courses. Dan explained that while some companion courses are too recent to have substantial data, Math 115C has been offered for a longer period. However, it's very difficult to gather meaningful data because of several biases. These include the fact that students can choose whether or not to take a companion course, and instructors can decide whether to teach with a companion.
- Gina further elaborated that, based on experiences with Math 115C, the format of companion courses varies depending on the faculty. Some companions serve primarily as extensions of the class time, while others focus on reviewing extra problems or skills. Dan noted that companions for Math 123C and 124C are more content-driven compared to Math 115C.
- Sara raised concerns about potential scheduling conflicts between companion courses and science course blocks. Dan responded that the current offering starts at 9:40am and ends at 11am. The companion will be added beforehand so the parent course will end at the same time and will not introduce new conflicts with science courses.
- Sara shared that students typically select course sections based on the class schedule itself rather than the availability of companion courses. A suggestion was made to coordinate a single companion course for the two sections of Math 124 to streamline scheduling and optimize resources.
- Cari recommended conducting an evaluation of the effectiveness of companion courses to ensure they are addressing student needs effectively. She also suggested standardizing companion course formats to provide students with a more consistent experience across different sections, as current approaches vary significantly.
