After attending the conference, she realized that some sort of resolution is important since many students (64%) don't purchase the textbook due to textbook costs. Other discussions included possibly marginalizing faculty members who choose not to use OERs, and if a resolution is created, then it should be as broad as possible.
- b. Letter to IT: VP Robinson explained that some of the IT maintenance dates on the COM website interfere with student registration activities. The last day to drop (based on Ed Code policy) was last Friday, and the students that tried to drop couldn't due to the website being down for maintenance. President Pasquel wants to write a letter to IT to make sure they look at the important dates of the semester.
